JOHN “GRIF” GRIFFITH was born in Minneapolis in 1945. He holds a Bachelor of Arts degree from the Minnesota State University Mankato in Speech and Theatre.

Griffith is the CEO of Empirehouse Inc., a glass and glazing company located in Mounds View, Minnesota, serving the upper Midwest. He also worked for PPG Industries in Milwaukee. He started in the glass business repairing broken windows, working his way through high school and college obtaining training to become a journeyman glazier. He is experienced in the business of metal and glass and its installation.

He served as a Park Board Commissioner for Robbinsdale for over ten years. He has also served as a Trustee for his church for over a decade.

Grif has held many positions in the Minneapolis-St. Paul Chapter, including President, Vice President, and Region Director, and has served as member or chair of numerous committees. He also was active in assisting the Minneapolis-St. Paul Chapter and the North Central Region when developing their long range planning programs.
