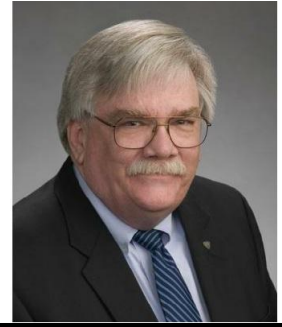


J. Peter Jordan, FCSI

J. PETER JORDAN was born and raised in Corpus Christi, Texas. He earned the BA and BArch degrees from Rice University in 1971, attended Princeton Theological Seminary, and earned an MBA from Georgia State University. After working in architectural firms in Texas, New Jersey, and Georgia, he was first registered as an architect in Georgia in 1975. His project experience includes destination resort hotels in Fiji, Palau and Australia, military facilities in Diego Garcia and Hawaii, commercial office and retail buildings in Hawaii, Guam, Texas, and Georgia, educational facilities for K-12 and higher education in New Jersey, Georgia, Texas, and Hawaii, apartments and condominium projects in Florida, Texas and Hawaii, and medical facilities in Georgia, Texas, and Hawaii.

Although he has mostly been involved in teaching or writing construction specifications since 1978, he also has managed an architectural firm's computer-aided design department: taught university courses in computer applications, design studio, architectural economics, and construction

specifications, and served as a project architect. In addition to his formal teaching responsibilities, he has made presentations on topics related to construction contracts and specifications to various architectural firms, CSI, AIA, and DBIA.

His involvement in computer-aided design led him to become a member of the Association of Computer-Aided Design In Architecture (ACADIA) where he served as Treasurer and President. He was the Technical Chair of ACADIA's annual conferences in 1990 and 1997, writing the call for papers, leading the selection of papers to be presented, and publishing the proceedings of each conference. He has also been a member of the AIA, actively participating in various activities in the Hawaii Society and the Honolulu Chapter.

He currently is President of Jordan Consultants, LLC, a firm located in Houston, Texas, providing specification consulting services to professional design firms, product distributors, and construction industry associations .
