In 1981, John and his wife, Lori, relocated to Omaha, Nebraska to take a position with Leo A. Daly where he was a production architect for several significant projects in Saudi Arabia and eastern United States.

In 1987, he was presented the opportunity to establish an architectural department for Lee & Batheja, a small civil/structural engineering firm in Omaha.

In 2007 he left the company and joined the Schemmer Associates as a Senior Architect and Project Manager in the Omaha Office.

John joined the Nebraska Chapter of CSI in 1990 where he soon became involved with the Product Show Committee which led to added responsibilities, becoming the Chapter

President in 1999. In 2002, following his tenure as Region Director for the Nebraska Chapter, he was asked to serve as the North Central Region Education Chair, continuing to hold the position through 2009. He became a MasterFormat™ Accredited Instructor in 2005, and made several presentations on the specification changes to various groups.
